## 84th ANNUAL MEETING VEC hosts another successful meeting

**COOPERATIVES** are guided by seven principles that are the foundation of our organization. Principle #2 is Democratic Member Control, which was on full display at our annual meeting. Members from across our service territory gathered to take part in cooperative business as a community – a cooperative community.

The 84th annual meeting of Vigilante Electric Cooperative, Inc. (VEC) was called to order by Cheyenne Garrison, VEC board president, on March 4th at the Beier Auditorium at the University of Montana-Western in Dillon, Montana. Garrison chaired the annual meeting and started by welcoming attendees and introducing special guests.

As part of a long-standing tradition, Trustee Norm Tebay presented the invocation. He was joined by the Montana Youth Challenge Academy Color Guard

presenting our nation's flag and the flag of the state of Montana. In what can be described as inspirational, Norm led the near 300 attendees in *America the Beautiful*.

After all of the formalities were completed, Garrison discussed the challenges faced by VEC. She touched on the work-related issues created by the pandemic, as well as supply chain and equipment shortages. She discussed the worsening drought conditions and wild-fire danger within our service territory, noting last summer's Deep Creek Fire that destroyed 3.5 miles of distribution line, and left affected members without power for 10 days.

Rates are always a topic of interest, and Garrison addressed this topic from

the board's perspective. While VEC has the lowest rates in the state, our current Bonneville Power Administration contract expires in 2028. She reassured members that the VEC board and management are actively researching the best options for future power supply.

She concluded her remarks by noting that the board has recently had meetings with local legislators to discuss issues facing our organization, and that they will soon be conducting a strategic planning session to analyze current data, prioritize needs and put a plan together to address these needs.

The meeting continued with Secretary Tom Mitchell presenting the financial report for 2021. The numbers that Mitchell reviewed were in last month's *Rural Montana* Magazine. Mitchell noted that VEC's financial position remains strong and stable, and that we experienced record sales for the year, which was a factor in providing another year-end rebate to the membership. He concluded with comments about the retirement of \$890,000 in capital credits in 2021.

Manager Rollie Miller spoke about this year's theme of "The Challenge of Change," adding depth to comments made earlier. Miller emphasized the number of new services in 2021, which nearly doubled our average, and that not only does VEC have the lowest rates in the state, but also some of the lowest in the country. He expects that VEC will likely maintain the current rate structure for another two years.

Rollie then discussed the proposed breaching of the four lower Snake River dams. They play a vital role in keeping VEC's rates low while providing clean and renewable hydroelectric energy. This is an important battle and we have to ensure that these dams are not breached.

Miller stated that safety is, and always will be, VEC's number one priority. He noted that VEC has had no recordable accidents in nearly six years, which is unprecedented for our organization. He also discussed the new dispatch service that VEC is using, which adds an extra layer of safety for our linemen and enhanced service to our membership.

Miller concluded with a discussion of our Safety Roundup program. VEC recently donated Safety Roundup funds to the Broadwater School District for the installation of a security light at one of the school district's remote bus stops. Miller also presented a Safety Roundup check for \$1,200 to the Lima School District to aid with the implementation of a mental health/suicide prevention program in the middle and high schools.

This year, we had two members request the opportunity to speak. Peter Reiss, a VEC member living in Broadwater County, presented his views against the breaching of the Lower Snake River dams. His career in aviation and aviation security provides him with a unique perspective on how a breach could affect event preparedness and energy-grid security. Beaverhead County Commissioner John Jackson thanked VEC for its assistance with setting up a flagpole at the Mountain View Cemetery in Dillon.

The next business on the agenda was trustee elections. Trustees serve three-year terms to ensure at least six experienced trustees at all times. Nominations occur at the district

meetings, with the election taking place at the annual meeting. This year's nominees were, from District #1, Norm Tebay (incumbent), from District #2, Dean Hanson (incumbent) and from District #6, Andy Johnson (incumbent). With all three incumbents running unopposed, unanimous ballots were cast for each.

Finally, we heard from Gary Wiens, CEO of the Montana Electric Cooperatives' Association (MECA). Gary discussed the proposed breaching of the Lower Snake River dams. These dams are beneficial to our environment and our economy, and Gary encouraged members to reach out to their legislators and let them know of their opposition to the proposed breach.

Gary also discussed other legislative issues that MECA is working on, including legislation that would promote the development and implementation of wildfire mitigation plans as a means of limiting liability on fires started in the utility right-of-way, as well as a proposal for preventing the sage grouse from being placed on the endangered species list.

Overall, this meeting was a remarkable success. We would like to thank Gary for taking time out of his busy schedule to participate in our meeting, the event and food services at the University of Montana – Western for their efforts and all the vendors that donated door prizes.

Finally, we would like to thank all of the members that attended the meeting; you truly honored us with your presence. **RM**
